**The Lima-Allen County Regional Planning Commission  
prepared and released for public review and comment  
Amendments to the FY 2016 – 2019 Transportation Improvement Program  
and the FY 2018 Unified Planning Work Program**

Lima, Ohio (February 27, 2017); The Lima-Allen County Regional Planning Commission (LACRPC) has prepared and released for public review and comment “Amendments to the FY 2016-2019 Transportation Improvement Program” (TIP) and the FY 2018 Unified Planning Work Program (UPWP).

At its January meeting, the Transportation Coordinating Committee (TCC) approved the following:

**Amendment to the FY 2016-2019 TIP:**

**Authorization to Increase FY 2019 Metropolitan Planning Organization (MPO) Funds - PID**

**99964** was amended to reflect an additional \$50,000 in STP funding during FY 2019 for a total of \$200,000 of STP funds at 100%.

**Draft FY 2018 Unified Planning Work Program (UPWP):**

The Draft FY 2018 UPWP details LACRPC work proposed to be completed between July 1, 2017, and June 30, 2018. It identifies nearly two dozen work elements, committing fiscal support from Federal, State, and local sources. The development of the FY 2018 UPWP is mandated by Federal regulations, but also serves to provide benchmarks from which to assess Commission progress and accomplishments. The UPWP details those LACRPC staff activities that will be conducted over the course of FY 2018 as specified under contractual obligation with various funding agencies. The UPWP is required to be compiled and submitted to State and Federal agencies as the basis for soliciting federal funding assistance.

The Amendments to the FY 2016-2019 TIP and the FY 2018 UPWP will be available for 21 days for review and comment during normal business hours at the Lima-Allen County Regional Planning Commission located at 130 W. North Street in Lima, Ohio. Staff is available to answer questions. The FY 2016-2019 TIP amendments and the Draft FY 2018 UPWP are both on the internet at [www.lacrpc.com](http://www.lacrpc.com).
