2. <u>APPROVAL OF DCC MINUTES – December 5, 2023</u>

Motion 90 (12-19-23) DCC

Steve Ewing made the motion that the DCC minutes of December 5, 2023, be approved. Seconded by Kevin Cox; motion carried.

3. APPROVAL OF AGENDA

Motion 91 (12-19-23) DCC

Jerry Gilden made the motion that the agenda be approved. Seconded by Kevin Cox, the motion carried.

4. STAFF RECOMMENDATION: Camden Ridge Subdivision Phase 2 – Final Plat

Mr. Haunhorst gave an overview of Camden Ridge Phase 2 Final Plat and gave staff recommendation of conditional approval on the basis that a maintenance bond and sidewalk bond are submitted. Mr. Gearing raised a concern regarding the rear setbacks and utility easements overlapping. Mr. Core clarified that a note had been placed on page one to address overlap. Mr. Haunhorst brought up the townships concern over turnaround compaction and stated this is an issue covered under a maintenance bond. Mr. Core further clarified the compaction status. Mr. Lause expressed further drainage concerns at the turn around. Mr. Core and Mr. Bowmn further elaborated on the turnaround status. Mr. Haunhorst stated that the applicant requested a 5 year sidewalk bond as apposed to a 2 year bond as is allowable in the Allen

County Subdivision Regulations. Mr. Cox asked for a completion timeframe clarification, Mr. Core clarified. Mr. Gearing asked for clarification regarding multiple lot purchase and sidewalk installation. Mr. Haunhorst clarified sidewalk installation requirements and bond coverage. Mr. Baxter raised concerns over sidewalk bonding and installation. Mr. Core offered reassurance. Mr. Gearing raised concerns over maintaining access to utilities and easements.

Motion 92 (12-19-23) DCC

Steve Ewing made the motion to accept the staff recommendation of Camden Ridge Subdivision Phase 2 – Final Replat. Seconded by Ron Meyer; motion carried.
