HOME WEATHERIZATION ASSISTANCE PROGRAM

This winter's cold weather is here, and forecasts for colder temperatures ahead may mean that some residents will need help to stay warm this winter. The Ohio Home Weatherization Assistance Program (HWAP) is a no-cost energy assistance program designed to increase the energy efficiency of dwellings owned or occupied by incomeeligible Ohioans, reduce participants' household energy expenditures, and improve participants' health and safety. HWAP is federally funded by the U.S. Department of Energy and provided Ohioans at no cost for customers whose annual household income



is at or below 200 percent of the federal poverty guidelines. Ohio's HWAP is administered through the Ohio Development Services Agency's Community Service Division (CDS) and its Office of Community Assistance.

After weatherization, households that heat with natural gas reduce space heating consumption by an average of 29 percent, and electrically heated homes reduce usage an average of 15 percent. Because of the weatherization installed in participants' homes, the percentage of utility bills paid was increased with the net result being the rate of utility service disconnections for this group decreased significantly.

Any individual, homeowner, or renter with an income at or below 200 percent of federal government poverty guidelines can apply for services under the HWAP. As required by the federal government, HWAP providers give priority to people over the age of 60, those with disabilities, those with children in the home, and households with high energy usage and/or burden. The local agency's review of your application will determine your eligibility for services. All families who have received assistance at any time during the last 12 months under the Supplemental Security Income (SSI), Temporary Assistance for Needy Families (TANF), or Home Energy Assistance (HEAP) (does not include Emergency HEAP) are automatically eligible for weatherization services.

Selected weatherization measures may be done to a home if one is determined eligible for services. A home inspection is completed to determine the most cost-effective weatherization services for each home. The services may include safety inspection, tune-up/repair, and if necessary, installation of heating units. In addition, projects may reduce air leakage from major sources and insulation may be added to attics, sidewalls, heating ducts, floors, and water tanks.

Ohio's HWAP is carried out by community action agencies. In Allen County, participation in the program is administered by the Hancock Hardin Wyandot Putnam (HHWP) Community Action Commission. OHIO SENATE SELECT COMMITTEE ON HOUSING

The Ohio Senate has formed a new select committee on housing that plans to address Ohio's housing crisis. The committee has been meeting since late August to determine what additional steps the state needs to take to encourage home ownership. The committee held several meetings in Columbus before beginning a statewide tour of both rural and urban communities with the most recent meeting being December 11th in Lima. Common themes found throughout testimony given by Allen County representatives include rising rents, infrastructure gaps for new development, aging housing stock, and lack of new development including single and multi-family homes and other high-density housing across all price points.

- Recommendations made by Allen County representatives included:

 Incentives for Housing Rehabilitation

 Gap financing for developers and neighborhood infrastructure grants

 Increased funding for affordable housing initiatives and down payment

 Support for homeless prevention programs

 Inclusive solutions that include the interests of all stakeholders.

 Reassess sales tax for building materials, introduce programs that leverage anticipated future tax revenue to make current day improvements. revenue to make current-day improvements

The Select Committee on Housing will continue meeting through late January or early February with plans to release a report in April followed quickly with legislative action.

SAFETY PERFORMANCE MEASURES

In compliance with the requirements of the FAST Act, the transportation bill passed by the U. S. Congress in 2015, the LACRPC, as the local MPO, is engaged in monitoring local progress toward achieving established targets for each of five federally/state-identified safety performance measures. The safety performance measures identified in the FAST Act include:

- The number of highway fatalities
- The rate of fatalities per 100 million-vehicle-miles-traveled (MVMT)
- The number of serious injuries
- The rate of serious injuries per 100 MVMT
- The number of non-motorized fatalities and serious injuries.

Mirroring the statewide goal set by the Ohio Department of Transportation (ODOT), the LACRPC committed to achieving a 2% reduction in CY 2024, using a 5-year rolling average (2019-2022) as a baseline in all five safety metrics. Throughout each year, the Commission closely tracks the incidence of fatal crashes as well as serious injury crashes, enabling the RPC to monitor performance measure attainment regularly. The Commission will work to achieve the new targets, continuing to partner with community stakeholders to implement crash-reducing countermeasures. Safety remains a priority! The Basics

Slow down. It's harder to control or stop your vehicle on a slick or snow-covered surface. On the road, increase your following distance enough so that you'll have plenty of time to stop for vehicles ahead of you.

Do not crowd a snow plow or travel beside the truck. Snow plows travel slowly, make wide turns, stop often, overlap lanes, and exit the road frequently. If you find yourself behind a snow plow, stay far enough behind it and use caution if you pass the plow.

What to Do in an Emergency

If you are stopped or stalled in wintry weather, stay focused on yourself and your passengers, your car, and your surroundings.

Stay in your car and don't overexert yourself.

Let your car be seen. Put bright markers on the antenna or windows and keep the interior dome light on.

Be mindful of carbon monoxide poisoning. Make sure your exhaust pipe is clear of any snow and run your car only sporadically — just long enough to stay warm. Don't run your car for long periods of time with the windows up or in an enclosed space.

Batteries

When the temperatures drop, so does battery power. In cold weather, gasoline and diesel engines take more battery power to start, and electric and hybrid-electric vehicles' driving range can be reduced. Have a mechanic check your battery, charging system, belts, and any other needed repairs or replacements.

Stock Your Vehicle

Carry items in your vehicle to handle common winter driving-related tasks, and supplies you might need in an emergency, including:

• a snow shovel, broom, and ice scraper;

- abrasive material (sand or kitty litter), in case your vehicle gets stuck in the snow;
- jumper cables, flashlight, and warning devices (flares and emergency markers);

blankets for protection from the cold; and

• a cell phone and charger, water, food, and any necessary medicine.
