**5. TIP, STIP, LRTP UPDATE**

Staff gave the following update concerning the TIP, STIP, & LRTP:

LACRPC staff is in the process of updating the Transportation Improvement Plan, State Transportation Plan, and the Long Range Transportation Plan. The first draft of the TIP is due February 1<sup>st</sup>. with the public comment period taking place March 9<sup>th</sup>- 31<sup>st</sup>, and the final submission date of April 25<sup>th</sup>. There are 37 STIP projects we will be submitting to ODOT. All of which have a PID.

This TIP update has 12 projects under consideration. This does not include two city and one county project which both have PIDs and five Pavement Condition Index projects. The Long Range Transportation Plan update conversations are still ongoing.
